

# Tuition Costs & Registration Form

Please be sure to read all information below before registering, and to save this page for your records.

**Refund Policy:** There are NO refunds or credits. In the case of illness or injury, tuition may be credited on a pro-rated basis upon doctor's confirmation. Tuition is non-refundable and non-transferable, and students who miss class or withdraw before the end of the semester are not eligible for a refund or credit.

**Registration and Release Form:** Registration forms should be fully completed, signed, dated, and returned to Nutmeg's. Forms must be returned with payment to secure a place in class. Classes are filled first come, first serve, and fill quickly; so please get forms and payment in early to avoid disappointment. Tuition may be paid with cash, check; or, you may register online to use a credit card.

**Late Tuition:** Tuition payments received more than 14 days past the due date, should include a \$10 late fee.

**Costume Payments:** Costume payments will be due in January.

**Returned Checks:** There is a \$25 charge for returned checks. After 2 returned checks, we require tuition to be paid with cash, money order, or certified check. Thank you.

**Course Cancellation:** We require a minimum of 5 students to run a class and reserve the right to cancel any course. Tuition will be refunded in full if the course has not yet begun, or on a pro-rated basis if the course has already begun.

**Fall Activities:** If your dancer is involved in a Fall activity, please understand that we are not able to save them a spot in class unless they have registered and paid from the start of classes. If you'd like to wait until Fall activities end to register, you are welcome to do so, as long as there is still space in the class. Thank you!

**Snow Policy:** In the case of school closings in the area, please always check our Facebook page after 2:00 PM to see if classes are being held.

There is no registration fee, and we never charge for rehearsal time.
